Once annually Serenity Solutions Lake Management will collect one (1) sediment sample and one (1) water sample to determine the phosphorus concentration for dosing nutrient in-activation.

Twice annually Serenity Solutions Lake Management will apply a nutrient inactivation product (Metafloc or equivalent) to bind phosphorus, the limiting nutrient stimulating algae growth in the Ponds along the casino entrance. This will aid in improving the water clarity as well and serve as a demonstration to understand the feasibility for a more substantial nutrient reduction effort. Nutrient Inactivation will be doses based on the manufacturers recommendation for hyper-eutrophic waterbodies.
